
Since its inception in 1998, Second Helpings has fought to create a bigger table in Central Indiana. That's 1 million healthy, delicious meals served to our most vulnerable neighbors each year, strengthening the bodies and minds of those who receive them and the bottom lines of the organizations who serve them.

Creating a bigger table means providing more opportunities for local residents to transform their lives. Through the Culinary Job Training program, Second Helpings continues to attack hunger at its source by providing a path to self-sufficiency for unemployed and underemployed adults.
